- 5. The bidswill be opened in the presence of Bidders' representatives who choose to attend at *14:00 hour on 7 January*, *2020* at the office of *Kalimati Rural Municipality Rampur*, *Salyan*.
- 6. Bids must be valid for a period of **90 days** and must be accompanied by a scanned copy of the bid security in .pdf format for e-bid, which shall be valid for 120days from the final bid submission date.If bidder wishes to submit the bid security in the form of cash the cash should be deposited in the bank account with the following information.
