7. The bid will be opened in the presence of Bidders' representatives who choose to attend at **14:00 hour on 15 September, 2020** at the office of **Kalimati Rural Municipality, Rampur, Salyan.**

Bids must be valid for a period of **90 days** and must be accompanied by a scanned copy of the bid security as specified above in pdf format for e-bid, which shall be valid for 120 days from the final bid submission date.
